

Honeywell GSM Radio Rebate Program

Thank you for choosing Honeywell. This flyer describes the procedures to follow to apply for a rebate for replacing Honeywell C-Series AMPS analog radios or other manufacturers' radios with Honeywell 7845GSM or 7845i-GSM digital radios. Due to the advanced technology of the AlarmNet network, we are able to make the rebate process simple and easy.

Rebate Process: Honeywell Analog Radio Replacements

The rebate procedure for replacing Honeywell AlarmNet-C (AMPS) radios with Honeywell GSM radios is very straightforward. Visit our website at www.alarmnet.com, click on the GSM Rebate Form link and enter the information requested on the Honeywell GSM Rebate Form; including your name, your company information, the ADI invoice number that the GSM radio was purchased on and details regarding the AlarmNet-C radio and the new GSM radio.

Single Rebate Requests:

After you enter your information onto the form, click on the "Submit" tab. The next screen you see will be a Rebate Request Confirmation screen that you should carefully review. If you notice anything that needs to be changed, click the "Edit" button to revise. Once you're certain the information is correct, **make sure the pop-up blocker on your computer is off before you proceed**, and then click "Confirm." Your information will be verified by our system. Once the information on the form is verified, you should print a copy of the completed form for your records. You will receive a \$30 rebate credit to your ADI account. The rebate credit will be applied to the ADI invoice that the GSM radio was purchased on. Allow 6-8 weeks for processing.

Multiple Rebate Requests:

If you would like to request a rebate for multiple radio replacements, after the first rebate request is completed click the "Add" tab. Your name and company information will remain on the online form, but the radio information will be cleared. Enter the details for the next radio, and follow the above procedure to complete the transaction. Use this process for each additional radio rebate request.

Rebate Process: Other Manufacturers' Radio Replacements

If you have replaced a radio from another manufacturer with a new Honeywell GSM radio, you are eligible to receive a rebate for this Honeywell GSM product purchase as well. Visit our website at www.alarmnet.com, click on the GSM Rebate Form link and enter your name, your company information and the ADI invoice number that the GSM radio was purchased on onto the Honeywell GSM Rebate Form. Then click on the "Other Manufacturers' Radio" button and provide all requested information regarding the radio from the other manufacturer and the Honeywell GSM radio.

Single Rebate Requests:

After you enter your information onto the form, click on the "Submit" tab. The next screen you see will be a Rebate Request Confirmation screen that you should carefully review. If you notice anything that needs to be changed, click the "Edit" button to revise. Once you're certain the information is correct, **make sure the pop-up blocker on your computer is off before you proceed**, and then click "Confirm." Your information will be verified by our system. Once the information on the form is verified, please print two (2) copies. Keep one copy for your records, and attach the second copy to the radio from the other manufacturer and ship it to us at the address listed below. All radios received without a completed Honeywell GSM Rebate Form will not be eligible for a rebate. Once we have received the radio and form, you will receive a \$30 rebate credit to your ADI account. The rebate credit will be applied to the ADI invoice that the GSM radio was purchased on. Please allow 6-8 weeks for processing after the product is received at Honeywell GSM Rebate Headquarters.

Multiple Rebate Requests:

If you would like to request a rebate on multiple radio replacements, after the first rebate request is completed click the "Add" tab. Your name and company information will remain on the online form, but the radio information will be cleared. Enter the details on the next set of radios, and follow the above procedure to complete the transaction. Use this process for each additional radio rebate request.
